Threatened Shorebird Nesting Off to a Strong Start

Two pairs of Piping Plovers have taken up residence at Shifting Lots Preserve, producing a total of eight eggs so far.

Unfortunately, the full moon tide around midnight on May 27th



washed away the first nest, just a few days shy of hatching. But it may not be too late for this pair to start over—piping plovers are resilient and they still have time to produce a successful brood. Least Terns too are scouting the beach area in possible preparation for a nesting colony as we saw last year.

As if these threatened shorebirds didn't have enough to reckon with between super-tides and predators, they face an especially frustrating human assailant this year. A night-time vandal has repeatedly slashed the fencing around the nests, as well as the dune fencing, since the end of March. The Wildlands Trust has deployed "digital surveillance" of the property. However, efforts to identify this miscreant have thus far come up short.

Friends Adopt a Multi-pronged Approach to Finding a Sustainable Solution

Restriction of tidal flows into and out of Ellisville Marsh has a negative impact on the salt marsh ecosystem and the wildlife that depend on it. What is the most sustainable solution to the recurring blockage of Ellisville Marsh's inlet – periodic inlet maintenance?... the reconstruction of the dilapidated state park rock jetty?... or, is there a softer "living shorelines" solution? Because one single strategy may be insufficient to the task, the Friends are pursuing all three concurrently. Our work, as shown in the graphic, includes:

- Permitting to allow continued inlet maintenance on an as-needed basis. No new permitting work is needed until 2024.
- Urging the Commonwealth to complete the inlet stabilization project which began in 2017 and has now languished.
- Exploring innovative "Living Shoreline" strategies for protection of the coastline and Ellisville Marsh itself —NEW! Read on...

Living Shoreline Initiative

Thanks to our first, multi-year respite from regulatory permitting work, we have launched a new initiative called "Living Shoreline." Living shoreline refers to a range of "soft armoring" techniques used to stabilize shorelines and protect or enhance natural features. These techniques seek to control erosion and flooding by recreating or enhancing natural shorelines using vegetation and other natural or

Current activities include contacting experts in the field, attending conferences, researching current Living Shoreline applications in New England (ongoing since 2018), and consulting with the Town of Plymouth to explore interest.
