NEW CORPS OF ENGINEERS PERMIT

We are pleased to report that after a lengthy delay the Friends finally received its new Massachusetts General Permit from the US Army Corps of Engineers in March. We're pleased to report we did not use an outside consultant this time. The new permit won't expire until 2020. The lateness of the permit precluded us from reopening the partially blocked inlet before the maintenance window closed March 31st. However, a subsequent storm greatly reduced the extent of the barrier spit that had formed back in February, giving us breathing room until next winter.

FRIENDS PARTNER WITH TOWN OF PLYMOUTH IN PURSUIT OF GRANT

The Town of Plymouth, spearheaded by the Department of Marine and Environmental Affairs, submitted in June a grant application under the Commonwealth's Coastal Resilience Grant Program, proposing to investigate a wide range of alternatives for maintaining the Ellisville inlet. If the application is successful, we'll be working closely with the Town and its outside consultant on this strategic initiative. A decision should be known by the time of our annual meeting on July 16th.

SAVERY POND A CONTINUING FOCUS

Savery Pond lies at the headwaters of Ellisville Marsh, to which it supplies freshwater via its outflow stream. The pond is a significant ecological resource; however, it suffers from recurrent blue-green algae blooms due to high concentrations of nutrients and low discharge to the stream. FEM began scientific sampling studies in 2012 to establish baseline conditions and identify potential causes of impaired water quality. Data collection continues this summer with the Town's placement of instrumentation.
